

**SAFARI CLUB INTERNATIONAL FOUNDATION
SPORTING CLAYS SHOOT SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE OR DONATION NECESSARY TO ENTER. A PURCHASE OR DONATION
WILL NOT IMPROVE YOUR CHANCES OF WINNING**

Eligibility. Open only to active US or Canadian members in good standing of Safari Club International (“SCI”) or Safari Club International Foundation (“SCIF” or “Sponsor”), or members of their immediate family, who are age 18 or older at time of entry. Employees of SCI and SCIF and members of their immediate family or household are not eligible. Void in Quebec, Canada and where prohibited, taxed, or restricted. This Sweepstakes is conducted in the United States and is governed by applicable US law.

How to Enter. This Sweepstakes begins on or about August 22, 2016 and ends on February 4, 2017 (“Sweepstakes Period”). There are three (3) ways to enter: (1) fill out an Official Sweepstakes Entry Ticket Form and follow all instructions to make a donation to SCIF of \$100 (USD). Entry Ticket Forms are available at the SCI board meeting August 24-27, 2016 in San Diego, CA and at the SCI Foundation Booth at the 2017 SCI Convention February 1-4, 2017 at the Mandalay Bay Convention Center, Las Vegas, Nevada (“Convention”); (2) register for the SCIF Sporting Clays Shoot which takes place on Tuesday, January 31st in Las Vegas to automatically receive one entry; or (3) To obtain one (1) free entry ticket, complete a 3 x 5 card with hand-printed name, address, age and daytime phone number, and either deposit it in the official entry box or hand it to a SCIF representative at the SCI Foundation Booth at the Convention, or mail it in a postage prepaid envelope address to Safari Club International Foundation, Sporting Clays Shoot Sweepstakes Entry, 4800 W. Gates Pass Road, Tucson, AZ 85745. Multiple entries per person/email address in excess of the entry limit, or any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to sweepstakes entry services) are prohibited and will void all entries by that entrant. Participation is limited to the first 360 entries received. All entries, regardless of method, must be received by SCIF by February 4, 2017 one-half hour prior to the announced time of the drawing. Entrant assumes risk of loss, damage, destruction, delay and misdirection of entries, and is solely responsible for postage due, illegible or incomplete entries. Once submitted, entries become the sole property of SCIF and will not be returned. By entering, you agree to be bound by these official rules and the decisions of SCI which are final and binding in all respects.

Drawing. One winner will be selected in a random drawing conducted by Sponsor (or its authorized representative) on February 4, 2017 at the SCI Foundation Booth, located at the Mandalay Bay Convention Center, Las Vegas, Nevada, from all entries received. You do not need to be present to win. If a Canadian resident is selected in the drawing, he/she must correctly answer a skill-testing question in order to claim the prize. The question will be administered upon notification to the Canadian resident that he/she was selected. To receive the prize, the questions must be correctly answered without assistance of any kind, within a specified time limit. Odds of winning a prize depend on the number of eligible entries received.

Prize/Odds of Winning. Prize (1): 32” Standard Grade K-80 Parcours shotgun. MSRP: \$11,695. Winner must be eligible for firearms possession, must comply with all applicable local, state, federal and provincial regulations and must make arrangements for delivery of firearms with appropriate federally licensed firearms dealers as required by state, federal/provincial law. If winner is a Canadian resident, he/she must possess and provide Sponsor with a copy of

his/her valid Canadian Firearms Possession & Acquisition License. Firearms prizes will not be awarded in any state or province where such prize is prohibited by law. If winner resides in any such state or province, prize will be forfeited and an alternate winner will be selected. Odds of winning depend upon the number of eligible entries received, but are no worse than 1:360. No cash/prize substitutions, except SCI reserves the right to substitute a prize of comparable value in the event of prize unavailability.

Conditions of Participation. Winner will be notified by email, mail or telephone (at Sponsor's discretion) and will be required to sign and return an Affidavit or Declaration of Eligibility and Liability/Publicity Release and any other documentation reasonably required by SCI/SCIF within 14 days of notification. In the event of noncompliance, if winner cannot be reached, or prize notification is returned as unclaimed or undeliverable, the winner may be disqualified and an alternate winner selected. All prizes will be awarded, assuming sufficient entries. No prize transfer permitted. All taxes, fees, and surcharges on prize are the sole responsibility of the prizewinner.
