

SAFARI CLUB INTERNATIONAL FOUNDATION COASTAL BLACK BEAR SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR DONATION NECESSARY TO ENTER. A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING

Eligibility. Employees of SCI, SCIF, individuals or entities involved in the implementation or execution of this Sweepstakes, and members of their immediate family or household are not eligible. Void in Washington, Quebec, Canada and where prohibited, taxed, or restricted. This Sweepstakes is conducted in the United States and is governed by applicable US law.

How to Enter. This Sweepstakes begins on or about January 1st, 2018 and ends at 2:00 p.m. Pacific Time on June 1st, 2019 ("Sweepstakes Period"). There are three (3) ways to enter: (1) fill out an Official Sweepstakes Entry Ticket Form and follow all instructions to make a suggested donation to SCIF of \$20(USD). Entry Ticket Forms are available at the SCI Foundation Booth at the 2019 SCI Convention January 9-12, 2019 at the Reno Sparks Convention Center, Reno, Nevada ("Convention"); (2) From January 1st, 2018 through June 1st, 2019, call Kimberly Byers during normal business hours at SCIF (520) 798-4891 with a valid credit card, to make a suggested donation to SCIF of \$20(USD); or (3) To obtain one (1) free entry ticket, complete a 3 x 5 card with hand-printed name, address, age and daytime phone number, and either (a) deposit it in the official entry box or hand it to a SCIF representative at the SCI Foundation Booth at the Convention; (b) between January 1st, 2018 through June 1st, 2019, mail it in a postage prepaid envelope addressed to Safari Club International Foundation, Coastal Black Bear Sweepstakes Entry, 4800 W. Gates Pass Road, Tucson, AZ 85745 (must be postmarked by June 1st, 2019 and received by June 7th, 2019, limit one entry per outer mailing envelope); or (c) beginning January 29, 2019 through 2:00 p.m. Pacific Time on June 1st, 2019, send an email to sweepstakes@safariclub.org. You must include "2019 Coastal Black Bear Sweepstakes Entry" in the subject line of the email, and include your name, address, age and daytime phone number in the body of the email. Limit fifty (50) entries per person regardless of the method of entry. Multiple entries per person/email address in excess of the entry limit, or any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to sweepstakes entry services) are prohibited and will void all entries by that entrant. Participation is limited to the first 4000 entries received. All entries, regardless of method, must be received by SCIF by 2:00 p.m. Pacific Time on June 7th, 2019 ("Entry Deadline"). Entrant assumes risk of loss, damage, destruction, delay and misdirection of entries, and is solely responsible for postage due, illegible or incomplete entries. Once submitted, entries become the sole property of SCIF and will not be returned. By entering, you agree to be bound by these official rules and the decisions of Sponsor which are final and binding in all respects.

Drawing. The question will be administered upon notification to the Canadian resident that he/she was selected.
