

SCIF 2022 EDUCATION SABLES AUGUST BOARD MEETING SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR DONATION NECESSARY TO ENTER. A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING

Eligibility. Open only to active US or Canadian members in good standing of Safari Club International (“SCI” or “Sponsor”) who are age 18 or older at time of entry. Employees of SCI and Safari Club International Foundation (“SCIF”) and members of their immediate family or household are not eligible. Void in Quebec, Canada and where prohibited, taxed, or restricted. This Sweepstakes is conducted in the United States and is governed by applicable US law.

How to Enter. This Sweepstakes begins on or about 8:00 am Central Time (CT) on August 15th, 2022 and ends at 12:00 pm CT (noon) on August 27th, 2022 (“Sweepstakes Period”). Purchase or donation is not required to enter the Promotion. Each entry must be received on or before 12:00 p.m. CT on Saturday, August 27th, 2022, to be entered into the drawing. Limit 25 entries per person, regardless of the method of entry.
