

**SAFARI CLUB INTERNATIONAL FOUNDATION
ULTIMATE SAFARI
SWEEPSTAKES OFFICIAL RULES**

NO PURCHASE OR DONATION NECESSARY TO ENTER. A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS GOVERNED SOLELY BY APPLICABLE U.S. FEDERAL AND STATE LAWS. ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

Eligibility. Open to individuals who are legal residents of the US (excluding Washington) or Canada (excluding Quebec) age 18 or older at time of entry. Employees of Safari Club International Foundation (“SCIF” or “Sponsor”), Safari Club International (“SCI”), individuals or entities involved in the implementation or execution of this Sweepstakes, and members of their immediate family or household are not eligible. Void in Washington, Quebec, Canada and where prohibited, taxed, or restricted. This Sweepstakes is conducted in the United States and is governed by applicable US law.

Timing. This Sweepstakes begins on or about 12:00:01 a.m. Pacific Time (PT) on April 24, 2025 and ends at 11:59 p.m. PT on June 30, 2025 (“Sweepstakes Period”).

How to Enter. There are five (5) ways to enter during the Sweepstakes Period:

(2) Call Kimberly Byers at SCIF during normal business hours (8 a.m. – 5 p.m. M-F) at (210) 512-8061 with a valid credit card to make a suggested donation to SCIF of \$20 (USD);

(3) Go to www.safariclubfoundation.org and sign up for the Forever for Wildlife Monthly Giving Program with SCI Foundation donation for a suggested minimum of \$25 per month (USD). You will receive one entry for every \$25 of monthly giving via the Forever for Wildlife Monthly Giving Program during the Sweepstakes Period.

(4) Call Kimberly Byers at SCIF during normal business hours (8 a.m. – 5 p.m. M-F) at (210) 512-8061 with a valid credit card and sign up for the Forever for Wildlife Monthly Giving Program with SCI Foundation donation for a suggested minimum of \$25 per month (USD). You will receive one entry for every \$25 of monthly giving via the Forever for Wildlife Monthly Giving Program during the Sweepstakes Period;

Mailed entries must be postmarked by June 21, 2025 and received by SCIF on or before June 30, 2025 (the “Entry Deadline”). Limit one (1) entry per outer mailing envelope. Limit fifty (50) entries per person regardless of the method of entry. Multiple entries per person/email address in excess of the entry limit, or any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to sweepstakes entry services) are prohibited and will void all entries by that entrant. All entries received through methods 1 through 5 above must be received during the Sweepstakes Period, and all mail-in entries must be received by June 30, 2025 (collectively, “Entry

Deadline"). Entrant assumes risk of loss, damage, destruction, delay and misdirection of entries, and is solely responsible for postage due, illegible or incomplete entries. Once submitted, entries become the sole property of SCIF and will not be returned. By entering, you agree to be bound by these official rules and the decisions of Sponsor which are final and binding in all respects.

Drawing. One (1) winner will be selected in a random drawing conducted by Sponsor (or its authorized representative) on or about July 15, 2025 from all entries received. You do not need to be present to win. If a Canadian resident is selected in the drawing, he/she must correctly answer a skill-testing question in order to claim the prize. The question will be administered upon notification to the Canadian resident that he/she was selected. In the event of noncompliance, if winner cannot be reached, or prize notification is returned as unclaimed or undeliverable, the winner may be disqualified, and an alternate winner selected. All prizes will be awarded, assuming sufficient entries.

Winner is responsible for all federal, state, provincial and local taxes in connection with his/her Prize. distributors, advertising agencies, prize providers, and each of their respective officers, directors, employees, and agents (collectively, the “Released Parties”) from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of the Prize. Except where prohibited, participation in the Sweepstakes constitutes the consent of a Winner to the Sponsor’s and its representatives’ or agents’ use of the Winner’s name, likeness, photograph, voice, opinions, biographical data, and/or contact information for promotional and other internal or external marketing purposes in any media, worldwide, without further compensation.

The Sponsor reserves the right, in its sole discretion, to disqualify any entrant it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. ANY ATTEMPT BY ANY PERSON TO DELIBERATELY UNDERMINE THE LEGITIMACY OF THE SWEEPSTAKES MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAW AND, IF THE SPONSOR BELIEVES, IN ITS SOLE DISCRETION, THAT SUCH AN ATTEMPT HAS BEEN OR WILL BE MADE, THEN THE SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. The Sponsor’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. These Official Rules cannot be modified or amended in any way except in a written document issued by a duly authorized representative of the Sponsor. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

Limitations of Liability: The Released Parties are not responsible for: (i) lost, late, stolen, misdirected, damaged, illegible, incomplete, garbled, or undelivered entries; (ii) fraud, technical problems, failures, malfunctions, or for any other technical problems or malfunctions associated with any telephone lines, computer systems, servers, provider hardware/software, lost or unavailable network connections or failed, incomplete, garbled or delayed computer transmissions or any combination thereof; (iii) any damage to any participant’s computer system/software related to or resulting from any participation or activity in connection with the Sweepstakes; or (iv) any incorrect or inaccurate information provided, published, or printed or any other factor beyond the Sponsor’s control that impairs the integrity or proper

functioning of the Sweepstakes as determined by Sponsor in its sole discretion. THE RELEASED PARTIES MAKE NO WARRANTY, GUARANTY, OR REPRESENTATION OF ANY KIND CONCERNING THE PRIZE (OR ANY PORTION THEREOF), AND (Y) DISCLAIM ANY IMPLIED WARRANTY.
